The Implementation Working Group (IWG), established to support the roll-out of INSPIRE: Seven strategies for ending violence against children, held its third quarterly meeting of 2023 on 7 September (see Appendix 1 for a list of participants).

#### **Purpose and objectives**

The meeting had the following objectives:

- For IWG members to reconnect and share developments and highlights
- Take stock of the IWG's progress on the five priority areas.



#### Sustainability of the coordination of the Working Group

At the June meeting of the Working group concern was raised about the continuity of the ISS as coordinator. Since then USAID, through the WHO has made a contribution to the coordination function of INSPIRE that will enable the ISS to continue in this role in 2024.



### The Global Partnership to End Violence Against Children developments

The Global Partnership to End Violence Against Children (abbreviated to the Global Partnership) is one of the core signatures of INSPIRE. The Global Partnership played a central role in the positioning of INSPIRE. INSPIRE and Pathfinding are closely aligned.

The IWG is aware that the Global Partnership is transitioning and this has implications for INSPIRE going forward. Dr Howard Taylor provided an update on the Global Partnership's transition and key developments from 2022–2023.

The Global Partnerships key initiatives are transitioning as follows:

 Pathfinding will transition to the UN Office of the Special Representative of the Secretary-General on Violence Against Children, Dr Najat Maalla M'jid.

2 Ending Corporal Punishments has transitioned and will be hosted by the World Health Organization (WHO).

3 The Positive Parenting work will continue within the Global Partnership until existing funds are dispersed.

- 4 The Safe to Learn initiative has transitioned to UNICEF.
- 5 Safe Online will continue to be hosted by UNICEF.

6 The products developed in the Childhood Sexual Violence and Investment case will be shared with partners.

7 A multi-stakeholder group is discussing the possibility of forming a new coalition to advance the global agenda of ending VAC.

All initiatives aim to be fully transitioned by the end of September 2023. A full statement on the Global Partnerships' transition can be accessed <u>here</u>.

## **INSPIRE evidence update**

The CDC provided a progress report on the INSPIRE evidence update. The WHO and CDC are leading this work.

The evidence update has three objectives:

- To systematically identify evidence reviews on the impact of INSPIRE interventions published from 2010.
- To provide clear recommendations on which interventions should be prioritised for scale-up.
- To identify evidence gaps and areas where higher quality evidence is necessary.

A total of 22 105 records, including grey literature, have been identified through a comprehensive data search. Title-abstract screening is currently underway.



UNICEF Innocenti sought clarity on whether the update would include the intersections between intimate partner violence (IPV) and VAC. CDC reminded the IWG that the research protocol for the update is available for <u>viewing online</u>. The review will include studies that captured IPV as a secondary outcome to VAC.

The University of Oxford emphasised that the majority of studies focusing on the intersections between IPV and VAC are either a) very recent, b) not yet published, or c) not yet captured in systemic reviews and will, therefore, not be included in the current INSPIRE update.

CDC stated that there is still an intention to include a crosswalk between VAC and VAW, as agreed upon at the 2022 Geneva meeting. The screening of each study and the completion of the update to the 'income and economic strengthening' strategy for IWG input is hoped to be completed by December 2023.

Since the meeting, UNICEF, CDC and others have met and shared resources that will strengthen the evidence update, including on the intersections between VAW and VAC.



## Brokering requests for technical assistance

The Working Group was reminded about the procedure for sharing technical requests.

If a Working Group member receives a request and would like to draw on the support of others in the working group, they should alert the coordinator to the request. The coordinator will inform the secretariat of the request and reach out to institutions and individuals in the IWG who may meet the need. The coordinator will record all requests and the outcome thereof (Figure 1).



The procedure was discussed and it was agreed that since many WG organisations provide technical support as part of their mandate, the protocol should also be followed if support to meet the requested need involves more than one IWG member. The intention is for this to be an opportunity to harness the collective resources of the IWG. Brokering requests for technical assistance is also an opportunity to:

- Disseminate the MOOC.
- Document adaptions and scale-up efforts in countries.
- To act as a thinking partner for countries.

The ISS asked whether the recording of requests was useful for IWG members. Joining Forces agreed that it would be helpful for the organisation to see what was taking place and if they could offer support in some way. USAID agreed, saying it would be a valuable tool to see where requests are coming from and to use it to advocate for funds.

The IWG agreed it would be helpful for the coordinator to continue tracking requests, and agreed that broader selection criteria should be developed by the secretariat for review by the IWG.





#### The capacity-building plan

INSPIRE-related capacity building is based on the following:

- The dissemination of the MOOC
- INSPIRE trainers
- Dissemination of the existing training materials

Disseminating training materials and the MOOC will contribute to further awareness and hopefully, uptake of the INSPIRE package. Most of the progress in relation to capacity-building pertains to the MOOC. CPC provided updates on the MOOC:

- CPC has received analytics on MOOC users, course completion and enrolment. Most MOOC users are female, have an advanced degree and are based in the USA. Users are from 135 countries.
- The MOOC will be reviewed in mid-late 2024 for additional changes and updates in accordance with the INSPIRE evidence update.
- The CPC is exploring options to increase access to the MOOC and welcomes suggestions from the IWG.
- In the short to mid-future, CPC will release a MOOC learner survey to access quality and learning.

• There are plans to translate the MOOC into French and Spanish.

The IWG offered the following suggestions about MOOC dissemination:

- Try to get the MOOC listed alongside other child protection courses. Incorporating the MOOC into curricula would be ideal.
- The timing of MOOC dissemination could be more strategic, for example, when countries start developing national action plans.
- Obligatory course completion can also facilitate completion, e.g., before in-country INSPIRE training.

There remains an intention to interview the people trained as trainers. USAID will support the IWG by providing interns to follow up with people who have been trained. The coordinator will meet with USAID to action this two weeks after the meeting.

Discussions between CPC and UNICEF are underway to explore how the MOOC can be integrated onto AGORA, UNICEF's online training platform.

#### Strengthening INSPIRE engagements

### The conversation on strengthening INSPIRE engagement centered on two key points.

- Developing a process for identifying and engaging in INSPIRE dissemination and uptake.
  - It was suggested to regularly map existing or upcoming engagements at global, regional and national levels.
  - Upcoming opportunities for 2024 include the Global Ministerial Conference, SVRI Conference and Parenting Summit.
  - There was a suggestion to produce a second version of the <u>INSPIRE Uptake</u> <u>Report</u> published in 2021.
  - USAID suggested developing an INSPIRE/IWG kit consisting of a slide deck on the IWG objectives and five priority activities, a factsheet and FAQs.

USAID, the University of Oxford and the ISS have met to action this and development of the material is currently underway.





# The INSPIRE communications strategy

This session continued the communication strategy as discussed at the Cape Town meeting.

At that meeting, the IWG identified key audiences for communication:

- Institutional donors
- High-net-worth individuals
- NGOs and civil society actors at both global and national levels
- Countries that have not yet taken up INSPIRE
- UN country offices and teams
- Academics who can help build up the evidence.

The IWG conducted a <u>virtual activity</u> to determine who in the key audiences should be targeted and when. The activity is captured in the table below.

- The ISS Communications person will draft a communications strategy.
